## CONGRATULATIONS, You are an accademia galli student!



The following procedures only apply to students who hold an Italian upper secondary school leaving qualification that was awarded in Italy. Foreign or Italian students with a non - Italian qualification should refer to the ADMISSION AND ENROLMENT PROCEDURES FOR STUDENTS HOLDING NON-ITALIAN UPPER SECONDARY SCHOOL QUALIFICATIONS AWARDED IN ITALY OR ABROAD.



## 1. ADMISSION REQUIREMENTS

#### **1.1 GENERAL REQUIREMENTS**

Accademia Galli awards 1<sup>st</sup> and 2<sup>nd</sup> Level Academic Diplomas recognised by the Italian Ministry of University and Research (MUR) - in the sector of Higher Education in Art, Music and Dance (AFAM), as well as private undergraduate IED Diplomas.

In order to be eligible for admission to a 1<sup>st</sup> and 2<sup>nd</sup> Level Academic Diploma programme or to an undergraduate Accademia Galli Diploma programme, students must:

- be proficient in the language of the chosen course (Italian/English) and comply with the language requirement listed in the relevant section below;
- hold an upper secondary school leaving qualification that satisfies the requirements for entering university education as listed in the relevant section below;
- not be enrolled in any other academic course at any other academy or university;
- be at least 18 years old by the end of the year in which the course starts;\*
- comply with the Accademia Galli admission and enrolment procedures.

\*if a student is under 18 years old when they make their application, the people with parental authority must submit a valid identity document and countersign all documents and a specific form provided by Accademia Galli.

#### **1.2 LANGUAGE REQUIREMENTS**

Accademia Galli 1<sup>st</sup> and 2<sup>nd</sup> Level Academic Diploma programs are taught either in Italian or English. Students are required to submit evidence of their knowledge of the language that the chosen Accademia Galli course is taught in (native Italian speakers applying for Accademia Galli courses taught in Italian are exempt from this).

The level required is B2 (as established by the Common European Framework of Reference for Languages - CEFR).

To prove their proficiency in the required language, the applicant must either:

- submit one of the accepted language certificates listed in the table below (the certificate cannot have been awarded more than 2 years before the application is made to the Accademia Galli);
- take the Accademia Galli language assessment (see the following section: **3.1 Accademia Galli IED Network** Language Assessment).

Accademia Galli reserves the right to verify the actual level of language proficiency through an internal language assessment when necessary.

#### 1.2.2 Exemption from Language Testing and Certificate Submission

**ENGLISH**: native English speakers who are nationals of the following countries are exempted from submitting English language certifications for the Accademia Galli courses taught in English\*:

- United Kingdom
- Ireland
- United States of America
- Australia
- Malta
- Canada (Québec excluded)
- New Zealand

\*In all cases, Accademia Galli reserves the right to verify the actual level of language proficiency through an internal language assessment when necessary.



#### 1.2.3 Language Gap and Prerequisite Language Course

Although the level of language required is B2, Accademia Galli also allows conditional admission to the first year of the course to students who can demonstrate **B1 level proficiency**.

These students must close the language gap and reach B2 level by May of the first year.

In order to prove attainment of the B2 level, they must either:

- submit one of the accepted official certifications **by 31 May** during the first year;
- attend the IED Prerequisite Language Course and pass the final exam, which must be taken **by 31 May** during the first academic year.

The IED Prerequisite Language Course aims to enhance conversation and vocabulary skills with a focus on specific design terms to allow for better participation in class.

The costs of the IED Prerequisite Language Course and of any extracurricular language courses chosen by the student are not included and must be added to the Accademia Galli undergraduate course enrolment and tuition fees.

The costs of the IED Prerequisite Language Course are included in the price list that is published yearly on the Accademia Galli - IED Network website (**www.ied.it**).

Students who do not reach the required language proficiency level that the course is taught in by the above - mentioned deadline will not be admitted to the second year and will need to re - enrol in first year.

For any questions regarding eligibility and/or language entry requirements, students can contact their Advisor.

#### **1.3 ACADEMIC REQUIREMENTS**

Students holding a five - year **Italian High School** Diploma (Diploma di Superamento dell'Esame di Stato conclusivo dei Corsi di Istruzione Secondaria Superiore) may enrol in the 1<sup>st</sup> and 2<sup>nd</sup> Level Academic Diploma courses (equivalent to a Bachelor of Arts Degree).

Three - year qualifications that are NOT considered eligible for admission to 1<sup>st</sup> and 2<sup>nd</sup> Level Academic Diploma courses include:

- Professional Diplomas (Diploma di Qualifica professionale);
- Diplomas of Maestro d'Arte.

#### PLEASE NOTE

In Italy, **double enrolment** in 1<sup>st</sup> and 2<sup>nd</sup> Level Academic Diploma/Degrees recognised by the Italian Ministry of University and Research is prohibited. Therefore, students enrolled at another university/academy before enrolling in a DAPL course at the Accademia Galli must have formalised the conclusion of their previous enrolment in one of the following ways:

- by requesting a transfer;
- by withdrawing from their studies;
- by finishing their studies and obtaining an academic degree;
- by having lost their student status.

For any questions concerning the eligibility of academic qualifications, students should contact their Advisor.

For the list of documents required for application, please see section **2.1** Application Documents. For the list of documents required for matriculation, please see section **5.2** Matriculation Documents.





## 2. APPLICATION PROCESS

In order to start the Accademia Galli application process, students should apply online on the Accademia Galli - IED Network website at **admission.ied.it/it/home** by requesting their login details from their Admission Advisor. If students do not have an Admission Advisor yet, they must ask for information directly via the web page for the relevant course.

Students must:

- Login to **admission.ied.it**
- Fill out the personal information section of the online application
- Sign the relevant sections:
  - ISEE Self-Declaration (only for students residing in Italy)
  - Self-Declaration of the Diploma or copy of the Diploma (if already awarded)
- Upload the document listed in the section 2.1.

The relevant Admission Advisor will check the uploaded documentation and will proceed with the following steps for the admission process.

#### **Suggested Timing**

The deadline to enrol into Accademia Galli programs for the a.y. 2022/2023 is set on September 30, 2022. Although enrolments are open until the above mentioned date, to comply with the Ministerial entry requirements, ensure Accademia Galli's quality level and guarantee effective interaction between teaching staff and students, Accademia Galli undergraduate courses have a restricted number of places available. To ensure a place on the course, students must have completed the enrolment procedure. Therefore, we strongly suggest starting the application process as soon as possible and that you also take into consideration that (where necessary) the Prerequisite language course will be held in September.

#### 2.1 APPLICATION DOCUMENTS

#### 2.1.1 Compulsory Application Documents

- Copy of Identity Document (valid ID card for EU citizens/valid passport for non EU citizens);
- Tax Code (only for Italian citizens);
- Self-Declaration or copy of the transfer certificate; withdrawal certificate or academic qualification (if already available), issued by the previous university (only for students previously enrolled in other universities);
- Personal statement in the language the chosen course is taught in (for more details, see sections **2.2 Personal Statement Guidelines**).

**Graduating students**: students who apply while still attending high school, and therefore before obtaining the necessary academic qualifications, must upload self-declaration or copy of the **secondary school leaving qualification** within the "Study Titles" section of their reserved area of IED Campus portal - accessible upon admission - no later **than 10 September**. The Self-Declaration must be uploaded ONLY ONCE the Diploma has been awarded.

#### 2.1.2 Suggested Documents

- Portfolio (max 8 MB);
- B2 certificate of proficiency in the language of the chosen course (if not available, the student will have to take the IED language assessment, with the exemption of native speakers).

For extra documents requested for the Transfer Procedure, please see the **Transfer Procedure** on the Accademia Galli - IED Network website.



#### 2.2 PERSONAL STATEMENT GUIDELINES

The personal statement will be the main topic of the interview and should outline the reasons that led the students to choose the course of study, the contribution that the students think they can make to said course and what they expect from the experience at Accademia Galli.

More specifically, students will be asked to expand upon the following 4 points:

- Briefly describe yourself: your personality, interests and aspirations.
- Explain your sources of inspiration and describe the expressive media that best represent them.
- Explain the reasons that led you to choose the course you are applying for.
- Tell us about your goals and how you think Accademia Galli can help you achieve them.

#### 2.2.1 Assessment Criteria for the Personal Statement

The personal statement will be assessed by a maximum of 40 points. The score will be based on the assessment of expressive abilities, argumentative abilities, originality and adherence to the contents of the above - mentioned guidelines.

#### 2.3 PORTFOLIO GUIDELINES (NOT MANDATORY)

Students who already have some personal work may choose to submit their own portfolio, structured according to the guidelines reported below:

To supplement your application, you can submit a digital portfolio, if you have one, that summarises your creative identity.

The portfolio will allow you to show the most relevant parts of your personality through your work. You can document your creative work across various fields, through pictures and a set of keywords or a short introductory text (500 words maximum).

Your portfolio can include drawings/illustrations, graphic design projects, photos, videos and any documentation regarding your own interests. The creative pieces of work you choose should indicate your creative potential and, if possible, provide some insight into your chosen area of study. Accademia Galli is more interested in the creative process and method used, rather than the end result. The creation of a visual framework is highly appreciated (presentation or slideshow). The use of keywords and short captions to go along with images is strongly recommended.

Digital format: PPT, PDF or personal websites (max 8 MB).





## 3. ADMISSION PROCESS

The admission process consists of:

- Accademia Galli IED Network Language Assessment (where necessary);
- Admission Interview.

#### 3.1 ACCADEMIA GALLI - IED NETWORK LANGUAGE ASSESSMENT

The level of language proficiency of students who do not provide a valid language certificate upon application (see section **1.2 Language Requirements**) will be tested through Accademia Galli - IED Network Language Assessment.

This language assessment aims to evaluate the language skills of the applicants and their capacity to reach the minimum level required at the beginning of the 1<sup>st</sup> year. The online assessment is carried out via a Skype conference with one of Accademia Galli - IED Network's language professors. The language assessment lasts about 20 minutes.

#### 3.2 ADMISSION INTERVIEW AND ADMISSION TEST

The purpose of the admission interview and of the admission test is to understand students' motivation and attitudes to undertaking the chosen Accademia Galli course. Accademia Galli will positively assess the applicants with the best potential, regardless of the strict consistency of their academic background. Strong motivation and a solid awareness of the content of the chosen Accademia Galli course are the best guarantee that students will get the most out of their undergraduate academic experience at the Accademia Galli. The admission interview aims to understand the motivation and personal attitudes of the student. It takes place with the Admission Advisor.

The **admission test** for the 1<sup>st</sup> **level Academic Diploma** is based on a written exam with questions regarding general knowledge in the field of the chosen Accademia Galli course aiming to evaluate the motivation and attitudes of the student.

The admission test for the 2<sup>nd</sup> level Academic Diploma is divided into:

- A graphic test;
- A visual perceptual test;
- A written exam with 60 multiple-choice questions regarding general culture, history of arts, chemistry, biology and English language knowledge.

#### 3.2.1 Assessment Criteria for the Admission Interview

The admission test and admission interview will be assessed by awarding a maximum of 30 points each.

#### 3.3 ADMISSION CONFIRMATION

Applicants' eligibility for admission will be determined after their personal statement and admission interview have been positively assessed (as well as the IED language assessment where required). If students who have passed the admission process prove to have obtained - or will obtain before the date of matriculation - a suitable academic qualification for enrolment, they will be **conditionally accepted** Accademia Galli course. Admission and subsequent enrolment **will remain conditional** until the Self-Declaration of the Diploma has been uploaded (as indicated within the Guide to Enrolment available on the Reserved Area of IED Campus portal) and Accademia Galli has verified the correctness. (See section **5** *Matriculation at Accademia Galli*).

Students whose assessment is positive and are therefore eligible for admission, will receive a notification of their admission to the course and their personal credential to access the Reserved Area of IED Campus Portal.

Within the portal, students will find:

- Matriculation Form;
- Guide to Enrolment;
- General Regulations;
- Disciplinary Regulations;
- Academic Regulations;
- Payment methods.





### 4. ENROLMENT

To ensure a place on the course, applicants must access the relevant section of the IED Campus portal and:

- Upload the matriculation form signed by hand;
- Upload the ISEEE certification if not yet provided;
- Pay the due fee amounts.

#### 4.1 CONFIRMATION OF ENROLMENT

Accademia Galli will verify the completeness and correctness of the enrolment documents provided by the student and will confirm the accomplishment of the enrolment.

Once the students receive the confirmation email from Accademia Galli, they will find the following documents in their Reserved Area:

- Invoice.
- For students residing in Italy and EU:
  - Enrolment Self-Declaration.
- For Extra-EU visa-seeking students:
  - Enrolment Certificate;
  - Accomodation certificate.

Extra-EU Visa seeking students will receive by courier the hard copy of the enrolment documents necessary for visa application.

**PLEASE NOTE**: students who applied to Accademia Galli while still attending high school, and therefore before obtaining the necessary academic qualifications, must upload the Self-Declaration or copy of the diploma within their reserved area on IED Campus portal no later **than 10 September**.

In any case, enrolment **will remain conditional** until the Self-Declaration has been uploaded in the reserved area of IED Campus portal. (See section **5** *Matriculation at Accademia Galli*).





## 5. MATRICULATION AT ACCADEMIA GALLI

students shall upload in the relevant sections of IED Campus portal the following documents:

- Self-Declaration of diploma;
- Self-Declaration or copy of the transfer certificate/withdrawal certificate (for students previously enrolled in other higher education institutions);
- Copy of valid residence permit (only for extra-EU students residing in Italy);
- ISEE certification (if not yet provided);
- Balance of the tuition fee by the relevant deadline (if still due).

Once the documentation has been uploaded by the students, Accademia Galli will verify the authenticity of the information declared and/or the certifications provided. If documents are missing, **students will be conditionally matriculated** and Accademia Galli will inform matriculating students that they need to complete their file. In such cases, the missing documents

must be submitted as soon as possible and compulsorily no later than **31 December during the A.Y.** of matriculation.

**CONDITIONAL MATRICULATION**: please note that failure to upload the overall required documentation within the reserved area of IED Campus portal, will result in your automatic inability to complete your matriculation at Accademia Galli and obtain your final diploma upon completion of your studies, even if you have passed the admission test. The students will be solely responsible for uploading the documents according to the specific requirements and deadlines.

If the documents submitted show that the qualification is not eligible for matriculation on the chosen course, Accademia Galli will notify the student.
